The career academy is a two week, forty (40) hour training program that provides job-readiness training, pre and post-placement services including job placement, education, skills and interest assessments, and personal and professional development. In 2017, 116 individuals were enrolled in the career academy and graduated.

Opportunity Staffing provides transitional employment for the career academy graduates. In 2017, 127 people were employed through Opportunity Staffing.
