**The career academy is a two week, forty (40) hour training program that provides job-readiness training, pre and post-placement services including job placement, education, skills and interest assessments, and personal and professional development. In 2020, 256 individuals were enrolled in the career academy and 172 graduated.**

**Blue Jacket Staffing provides transitional employment for the career academy graduates. In 2020, 199 people were employed through Blue Jacket Staffing.**
